




Revelation and the Apocalypse in Late Medieval Literature

The book will be of particular interest to undergraduates, postgraduates, academics, as well as the general reader who are interested in medieval/apocalyptic literature, Christianity, theology, history, and gender issues.

Blurb:

This interdisciplinary book breaks new ground by systematically examining ways in which two of the most important works of late-medieval English literature – Julian of Norwich's *Revelations of Love* and William Langland's *Piers Plowman* – were borne from engagement with the biblical Apocalypse and exegetical writings. This study contends that the exegetical approach to the Apocalypse is more extensive in Julian's Revelations and more sophisticated in Langland's *Piers Plowman* than previously thought, whether through a primary textual influence or a discernible Joachite influence. The author considers the implications of areas of confluence, which both writers reapply and emphasise – such as spiritual warfare and other salient thematic elements of the Apocalypse, gender issues, and Julian's explications of her vision of the soul as city of Christ and all believers (the fulcrum of her eschatologically-focused Aristotelian and Augustinian influenced pneumatology). The liberal soteriology implicit in Julian's 'Parable of the Lord and the Servant' is specifically explored in its Johannine and Scotistic Christological emphasis, the absent vision of hell, and the eschatological 'grete dede', vis-à-vis a possible critique of the prevalent hermeneutic.

- It will provide insight into the influence of the biblical Apocalypse upon the literature of the period in a systematic way.
- Importantly, by treating the writings of Julian of Norwich and William Langland as contemporaneous the book balances the female and male approaches to and engagement with the biblical Apocalypse.

Author Details:

Justin M. Byron-Davies completed his PhD at the University of Surrey in the United Kingdom, where he worked as an associate tutor in English literature and lectured on late medieval writings. His research interests include medieval theology and anchoritic, revelatory and apocalyptic texts.





Dylan Thomas's reputation precedes him. In keeping with his claim that he held 'a beast, an angel, and a madman in him', interpretations of his work have ranged from solemn adoration to dubious mythologising. His many voices continue to reverberate across culture and the arts: from poetry and letters, to popular music and Hollywood film. However, this wide and sometimes controversial renown has occasionally hindered serious analysis of his writing. Counterbalancing the often-misleading popular reputation, this book showcases eight new critical perspectives on Thomas's work. 



Blurb:

Ron Berry [1920–97] is one of the most remarkably astute yet relatively neglected twentieth-century Rhondda writers. An avid walker, birdwatcher, 'potcher', sportsman and miner, Berry is the product of a distinctive Rhondda landscape; the formidable peaks of Pen Pych and Cefn Nant y Gwair were to be a continuing source of inspiration for him in his writing. His idiosyncratic viewpoints, of which there are many, are reflected in both his memoir and fiction. As the first sustained critical study of his work, this collection seeks a literal, physical and chronological 'zooming-outwards', from the man himself to the personal and literary geographies and communities in which he was posited, to his creative legacy.


