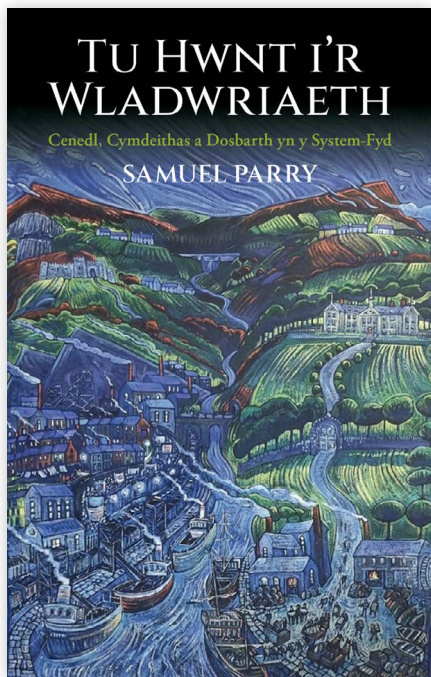

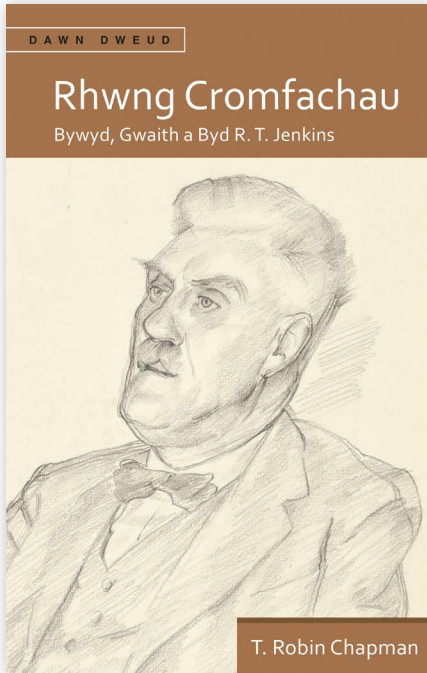

Chwilia rhywun yn ofer am broffwydoliaeth na galwad i’r gad ganddo ar y pynciau llosg a gyffrôi ei gyfoeswyr yng nghanol yr ugeinfed ganrif: cyflwr a dyfodol cefn gwlad ac addysg, crefydd a’r iaith Gymraeg – a Chymru ei hun. 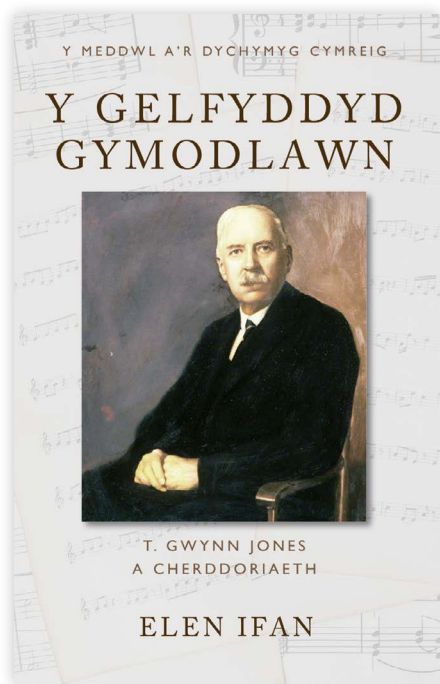

Ganed Catrin o Ferain yng ngogledd-ddwyrain Cymru ym 1535, mewn cyfnod hanesyddol gythryblus. Bu'n rhaid iddi droedio'n gyfrwys ac yn ofalus gydol ei hoes. Yn aeres gyfoethog o'i chrud i'w bedd, priododd yn dda, a'i blaenoriaeth oedd gwarchod ei hetfeddiaeth. Gyda'i hail ŵr Rhisiart Clwch, teithiodd Catrin yn helaeth ar draws cyfandir Ewrop, ac fe baentiwyd y darlun enwog ohoni pan oedd yn Antwerp. Bu'n weddw deirgwaith, ond tristwch mwyaf ei bywyd oedd y cyhuddiad yn erbyn ei mab hynaf o fod yn fradwr, a'i farwolaeth erchyll ar grocbren Tyburn ym 1587. Bum mlynedd yn ddiweddarach, yr oedd Catrin hithau wedi'i chladdu. Yn ystod ei hoes, defnyddiodd Catrin y gyfundrefn farddol i hyrwyddo ei henw da, a dadlennol a difyr yw'r dyfyniadau sy'n britho'r cofiant. Rhyfeddol hefyd yw'r dystiolaeth sy'n dangos y cyfeillgarwch dwfn rhyngddi a'r bardd Wiliam Cynwal, ac mae'r gyfrol arloesol hon yn cyplysu tystiolaeth weledol y cyfnod modern cynnar gyda barddoniaeth Beirdd yr Uchelwyr.

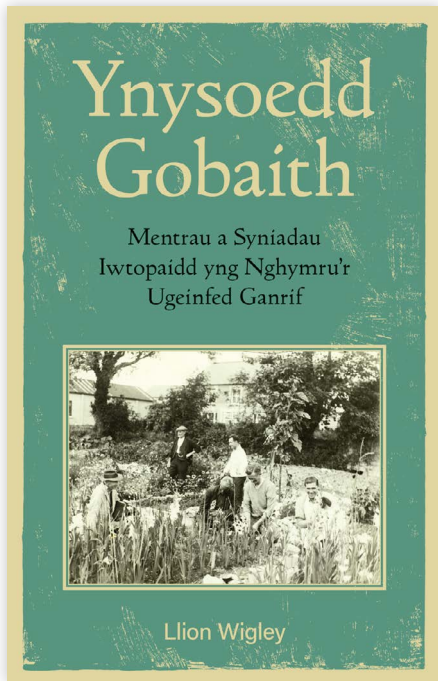

Gwynn Jones: cefndir cerddorol rhai o gerddi Caniadau; y rhai cannoedd o gyfieithiadau o eiriau caneuon; ymwneud y bardd â cherddoriaeth draddodiadol; a'r cydweithio helaeth fu rhyngddo a W. S. Gwynn Williams, sylfaenydd Cwmni Cyhoeddi Gwynn. Mae'r gyfrol yn ymdrin â thestunau cyfarwydd ac anghyfarwydd, ac yn cynnig gwedd gwbl newydd ar waith un o feirdd pwysicaf Cymru'r ugeinfed ganrif.

Each chapter offers an analysis of SFT from the eight major regions of the world in order to explore why certain subgenres (e.g., science fiction or horror) predominate, and how this knowledge can help us cultivate a better understanding of what is chosen for translation and how it impacts a domestic market. This is the only study to capture the global diversity of the genre, offering readers an accessible entry into the world of SFT and inspiring scholars to further research in the field.

This volume examines the psychology of fascism and its intrinsic relationship with the Gothic through the close study of propagandistic narratives by Spanish fascist women during the 1930s and 1940s. With close readings of women's magazines, novels and prison diaries, Gothic fear and monstrosity are for the first time showcased as fundamental tropes within the fascist political strategy of Francisco Franco's dictatorship. As both objects and agents of the fascist regime, the women in charge of the Spanish Women's Section collaborated with the Catholic Church on a series of magazine columns and educational campaigns, evoking a nightmare landscape rooted in the perceived evils of twentieth-century feminism, and using Gothic motifs to persuade other women to join the fascist cause. By its study of these motifs, *Fascist Female Gothic* demonstrates the political power of the Gothic, and sounds warning against a return to the rhetoric of fear in the turbulent sociopolitical present.

Heidi Backes is Professor of Spanish at Missouri State University. She specialises in Spanish Gothic fiction, focusing her latest research on the Gothic literary portrayal of twentieth-century Spanish fascism.

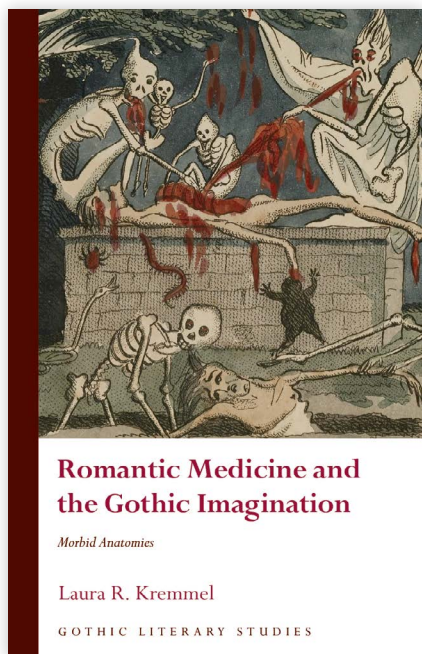

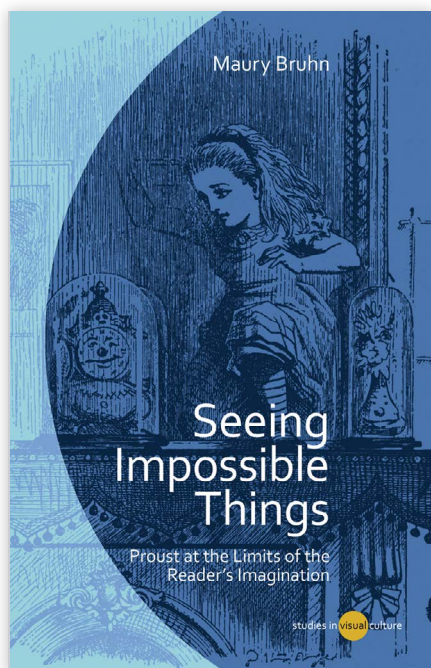

This book debates a crossover between the Gothic and the medical imagination in the Romantic period. It explores the gore and uncertainty typical of medical experimentation, and expands the possibilities of medical theories in a speculative space by a focus on Gothic novels, short stories, poetry, drama and chapbooks. By comparing the Gothic's collection of unsavoury tropes to morbid anatomy's collection of diseased organs, the author argues that the Gothic's prioritisation of fear and gore gives it access to nonnormative bodies, reallocating medical and narrative agency to bodies considered otherwise powerless. Each chapter pairs a trope with a critical medical debate, granting silenced bodies power over their own narratives: the reanimated corpse confronts fears about vitalism; the skeleton exposes fears about pain; the unreliable corpse feeds on fears of dissection; the devil redirects fears about disability; the dangerous narrative manipulates fears of contagion and vaccination.

What do we see in our mind's eye when we read Marcel Proust's *À la recherche du temps perdu*? The *Recherche* is full of objects behaving strangely, visual perspectives shifting unexpectedly, new dimensions opening within the familiar, and the lines between imagination, memory and perception blurring and collapsing. The present study argues that to see Proust's universe, the reader must work to visualise the hitherto impossible, testing their cognitive prowess against dense descriptive challenges. Its chapters analyse how Proust's descriptions of material, space, energy and time guide reader visualisation, demonstrating how clusters of these descriptions have the aggregate effect of expanding the reader's imagination beyond its habitual conceptual constraints. *Seeing Impossible Things* ultimately proposes that the unity of the *Recherche* lies not in an accumulation of meaning in the form of an overarching theory of aesthetics, but in an accumulation of imaginative practice culminating in the novel's final image.

This book offers a structural and *longue durée* analysis of Wales, Catalonia, the Mezzogiorno, and Padania, as regional configurations of the capitalist world-system. 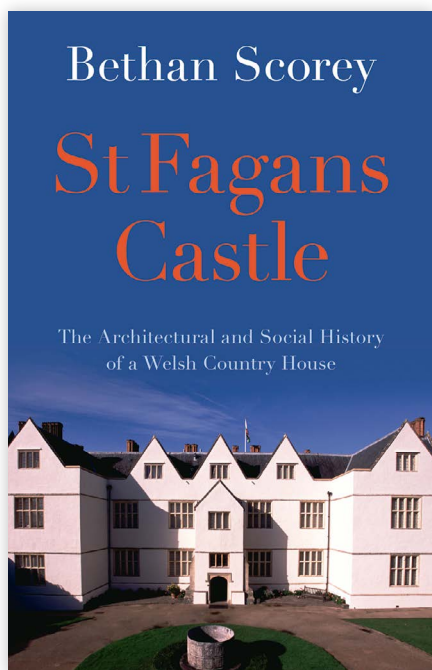

This is the first comprehensive study of St Fagans Castle, an Elizabethan country house in Cardiff which is of twofold significance as a Grade I-listed building, and home to St Fagans National Museum of History since 1948. The house was built by a local lawyer named Dr John Gibbon in about 1580, and was one of the first symmetrical country houses in Wales influenced by the Italian Renaissance. This study takes a multi-period and cross-disciplinary approach to telling the story of St Fagans, with chapters spanning the twelfth to the twentieth century, and interrelated sections on architectural history, garden history and ownership.

Key themes explored in the work include the impact of the Italian Renaissance on country houses in Wales; the architectural character of country houses in Wales, especially in comparison with English country houses; the contribution of women to architectural and garden developments at St Fagans; and the colonial connection at St Fagans.

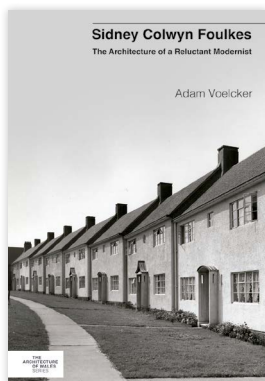

Today, the numbers professing Christian faith in Wales have reached an all-time low. In the 2021 Census, although 43% of the Welsh population described itself as 'Christian', less than 7% regularly attend a service of worship. This is a remarkable reversal of fortunes given the dominant role Christian faith, especially nonconformity, played in Welsh life throughout the eighteenth and nineteenth centuries. This book is the first holistic study of twentieth-century Welsh evangelicalism, and applies a series of case studies to demonstrate that religious decline and declension have been far from universal. In-depth study of the Evangelical Movement of Wales, the Evangelical Fellowship in the Church in Wales, the Charismatic renewal and Evangelical Alliance Wales, reveals that while Wales's evangelicals have sometimes retreated from Welsh society, they have also been marked by resurgence, renewal, re-engagement, reorientation and reinvention. By focusing on endurance rather than decline, this study illuminates how Wales's evangelicals have continued to maintain a vibrant presence in contemporary Welsh society.
